ANNUAL E-GOVERNANCE REPORT 2022-2023

1. Administration:

- 1. e-office:** College office proceedings regarding administration are corresponded by e-communication only with the support of digitalized office. By the direction of CCE and District Collector e-office was commenced.
- 2. Biometric Attendance System:** Staff members use biometric attendance to mark their attendance to the campus. These attendance records also help us to generate leave records.
- 3. On Line Teaching Learning Process(OTLP) Monitoring System:** For the implementation of online teaching learning process, an android application is developed by CCE, Govt. of Andhra Pradesh. Using the application, the faculty can post the attendance of classes regularly as per time table of the college. The application helps to maintain accountability and credibility of the lecturers towards teaching learning process.

2. Finance and Accounts:

- 1. Comprehensive Financial Management System (CFMS):** Government of Andhra Pradesh introduced a digital platform for e-governance in financial transactions which is called comprehensive financial management system (CFMS) from 2018-19 financial year and made it compulsory to adopt it. Consequently College runs all financial transactions including salaries, Scholarships, purchases etc. through CFMS only.

2. **Government electronic Market (GeM):** To Procure the infrastructural and laboratory equipment in a transparent manner we are using GeM Portal which is a central government market place.

3. Student Admission and Support:

1. **Online Admission Module for Degree Colleges (OAMDC):** The OAMDC is an Online admission module for Andhra Pradesh degree Colleges. Students who were eligible could check details and apply online with the necessary information on the official web portal.
2. **Biometric Attendance System:** Students use biometric attendance to mark their attendance to the campus. Biometric attendance was linked with scholarships of the students.
3. **Online Scholarships Portal (Jnanabhumi):** Scholarships are distributed through online mode. No student will get scholarship unless they were admitted through online.
4. **Online Grievance Redressal mechanism :** Both College and CCE ensures the highest standards of integrity and transparency and positive work culture in dealing with the grievances of the stakeholders by collecting the grievances in online mode
5. **Online fee payment App (F-Map) :** The online fees payment software sends is used by students for paying fees. Software sends auto-generated pending fees-related reminders & notifications to parents every month or at a pre-defined time. Also, the fees software generates an e-receipt after every successful transaction & sends it to their registered email ID or mobile.

4. Examinations:

Affiliated University facilitates for announcements regarding examination notification, time table and declaring the results through its website. Further these announcements are also placed in college website and also posted in common WhatsApp groups of students. Even for information

regarding internal examinations, assignments, student's projects and any matter regarding examinations and its related grievance, the common WhatsApp groups of students are being utilized.
