The Correspondents of Aided Degree Colleges and Regional Joint Directors of Collegiate Education in the State are informed that Government promulgated A.P.Ordinance No.13 of 2022, dated: 29.11.2022 issued amendement to Section 78-A of A.P.Education Act, 1982 Called the Andhra Pradesh Education (Amendment) Ordinance, 2022.It shall be deemed to have come into force with effect on and from the 1st January 2022.

The Provisions of the said Ordinance are as follows:

"that every teacher or member of the non teaching stazff employed in any aided private educational institution, who retired from service on attaining the age of sixty years on and from 1st January, 2022 to the dazte of publication of the Andhra Pradesh Education (Amendment) Ordinence, 2022, shall be re-inducted into the service/post as such with effect from the date of publication of the said Ordinance;

Provided further that the said interregnum period from the 1st January, 2022 to the date of the publication of the Andhra Pradesh Education (Amendment) Ordinance, 2022 shall be treated in such manner as may be prescribed".

Therefore, the Regional Joint Directors of Collegiate Education

in the State are requested to re induct such of aided employees (both Teaching and Non teaching) in to service who retired on attaining the age of superannuation of 60 years on and from 01.01.2022, with effect from the date of publication of the said Ordinance.

However, orders will be issued for the interregunum period from the 01.01.2022 to the date of publication of the Ordinance, separately by the Government.

The Correspondents of all Aided Degree Colleges are also requested to implement the provisions of the A.P.Education (Amendment) Ordinance, 2022, scrupulously.
